Pioneers of Lafayette County, WI Certificate

Sponsored by the Lafayette County Historical and Genealogy Society

The Lafayette County Historical and Genealogy Society will issue a Pioneer Certificate to the qualifying direct descendants of the early settlers of this county. Many of the early pioneers have gone unrecognized by Lafayette County. It is not necessary for the applicant to be a resident or have ever been a resident of Lafayette County.

To qualify, the applicant **must prove descent** from an early pioneer who settled in Lafayette County, Wisconsin during the following years: (The certificate will be awarded accordingly.)

Before 1847* - Pioneer Certificate with gold seal.

1847 – 1877- Early Settler Certificate with blue seal.

1878 – 1897 - Centennial Certificate with red seal.

*Lafayette County was organized in the spring of 1847.

Instructions

- 1. Complete the application and the lineage chart as fully as possible. Use maiden names for women if known. Designate with a question mark any data that is questionable. The documentation you gather will help you fill out the application.
- 2. Documented proof of your ancestor's residency **and** your lineage must accompany the application.

At least one official record of residency must be included such as:

- <u>Land Record:</u> Photocopy of Deed with Deed Book number and page number or reference to Public Doman Land Sales Record Book.
- Census Record: Include Township/District, page and dwelling number.
- County Histories: Include title, author and page number.

Other acceptable sources to prove residence or lineage:

- Birth, Marriage and Death Record: include photocopy of the original document.
- Probate Record: include copy of will or other papers showing relationship to deceased.
- Obituaries: identify newspaper, date of publication and page number.
- <u>Church or School Records</u>: give location.
- Tax Records:
- <u>Tombstone Inscriptions</u>: give location of cemetery.
- 3. Additional information on your family may be included as you deem essential. Please **submit only** photocopies of the material as they will not be returned but become the property of the Lafayette County Historical and Genealogical Society.
- 4. Mail each completed application and the documentation along with \$5.00 for each certificate. Make checks payable to the Lafayette County Historical and Genealogy Society.
